## Application for Membership by a Club

A club wishing to become a member of Bushwalking Victoria Incorporated should appoint a member to make the application on its behalf. Membership is available under the following two categories:

**Affiliate:** This provides full membership of Bushwalking Victoria, and entitles the member club to full services and benefits including voting rights, BWV insurance and membership inquiry referrals. Members of affiliated clubs may also nominate for office or board positions.

Affiliated membership is open to any body or association, whether incorporated or unincorporated, that in the opinion of the Board has Bushwalking as its major activity, agrees with the objectives of Bushwalking Victoria and has a membership of no less than ten persons. Annual fees are currently \$9.75 per club member aged 16 and over.

**Associate:** This category of membership may be granted to any body or association that does not have Bushwalking as its major activity. Associate members are not eligible for BWV insurance or have no voting rights. Members of associate clubs are able to participate on BWV committees and activities such as Search and Rescue, Bushwalking advocacy and conservation projects.

Both affiliates and associates have access to free publications for their members. Annual fees are currently \$82.00 for clubs with up to 20 members, \$141.00 for 21 to 50 members, and \$369.00 for over 50 members.
